

Appropriate Authority/Driving License or Passport & should also attach photocopy with the application. The qualification of candidates should be prior to the last date of filling the application. Work experience should be post qualification. The candidate will be employed on the condition that he/she maintain HQ and his/her job is non-transferable. Reservation for the above cited posts will be as per Haryana Govt. Rules. Engagement of candidate should be strictly on performance basis. Quarterly appraisal of performance will be carried out and if found unsatisfactory the service can be terminated. No separate information will be sent to the candidates for the interview.
