1. Candidates applying for a post must ensure that they fulfill all the eligibility conditions.
2. Candidates are instructed to bring **any three original** and attach attested/ self attested copies of residence proof with application form out of below mentioned documents i.e.
 - (I)Passport
 - (II)Election Card ID Card
 - (III)Ration Card with Address
 - (IV)Bank Passbook/Post Office Passbook
 - (V) Caste and Domicile Certificate with address and the photo issued by State Govt.
 - (VI)Parivar Pehchan Patra,
 - (VII)Electricity Bill (not older than last three months).
3. No TA/DA will be paid for attending Written Test.
4. Written test will be conducted for screening of the candidates and those candidates who are unable to get 40% in screening/proficiency test will **not be** shortlisted for further process of recruitment. Written test/Screening test/proficiency test is a test to check IQ, General knowledge and information of the candidate about concerned subject. Minimum 40% marks are mandatory to qualify the written examination & Computer Test each. The candidate who will qualify the written test will only be eligible for Computer Test.
5. Candidates are required to bring Blue Ball Pen for attempting of the written test. Mobile Phone or any other Electronic Item(s) will not be allowed to carry during the screening Test.
6. Reservation criteria will be as per Haryana Govt. policy. Candidates claiming reservation should submit the copy of caste certificate issued by the competent authority.
7. Candidates are instructed to visit web site nhmharyana.gov.in regularly for any update/change/corrigendum (If any), as no separate communication will be sent for this.
8. Number of posts can be increased or decreased.
9. Civil Surgeon / Concerned Incharge can assign duty at any other place besides place of posting within the district in public interest.
